Location

Huddersfield is a thriving commercial centre situated some 15 miles south west of Leeds, 8 miles south of Halifax and 10 miles south of Bradford. The town benefits from excellent communications, being close to junctions 23 and 24 of the M62.

Market Avenue links pedestrianised New Street to Victoria Lane, and is home to a range of boutique independent occupiers. The scheme also includes Virgin Media and Yorkshire Linen Company, whilst the Marks & Spencer Food Hall is adjacent.

Description

Market Avenue is a covered shopping arcade within the heart of Huddersfield town centre. The various units provide ground floor retail units, some with ancillary first floor accommodation. All units have glazed ground floor display windows.
