



Location

The site benefits from being less than 40m from Linthorpe Road, one of the main arterial routes in central Middlesbrough. Linthorpe Road plays home to numerous bars, restaurants and shops, making it an ideal location for Teesside University students. The university campus itself is less than 700m to the north east of the site. The entire northern boundary of the site adjoins a park, providing excellent unrestricted views for each bedroom.

The A66 is 950m to the west making access to the rest of the region quick and simple. Transport by rail is also excellent with Middlesbrough train station being less than a mile to the north.
