LOCATION

Brentford is located approximately 8 miles west of London and 1 mile west of Chiswick, off junction 2 of the M4. Its location is ideal for accessing Central London and the national motorway network.

West cross Industrial Park directly fronts the A4, 0.5 miles from junction 2 of the M4. Heathrow Airport is approximately 7.5 miles to the west, Syon Lane station (national rail) is 0.3 miles to the south and Boston Manor and Osterley station (Piccadilly Line) are 1.4 miles away.

DESCRIPTION

Mid terrace unit of steel portal frame construction. Fitted offices are provided at first floor with flexible under croft accommodation allowing further office space, trade counter, low height storage or welfare.

The warehouse benefits from: 6.50m clear height rising to 10m at the apex,, warehouse lighting and goods access via a new up and over sectional loading door.

Externally there are 12 allocated car parking spaces along with a generous loading apron.
