DESCRIPTION

The subject premises provides second floor commercial space which in part has been recently refubished to a good standard, situated in the heart of Wigan Town Centre close to many local amenities and main transport links. The building is currently fitted out for use as offices but is suitable for a variety of uses subject to planning permission including both leisure and retail.

The whole floor can be taken in its entirety but the space can also be taken on a room by room basis. The suites benefit from gas central heating, suspended ceilings, perimeter trunking, carpeting and well appointed male and female WC facilities.

DDA access could be provided if required and the Landlord is open to undertaking further refurbishment works subject to the terms agreed.

LOCATION

The subject premises are located above Little Fifteen and D'Empire on Wallgate, a busy street in the centre of Wigan which benefits from high levels of passing traffic and footfall. It is close to both Wigan North Western and Wigan Wallgate train stations and only a short walk to the local bus station and the Grand Arcade shopping centre.

Car parking is available on site and the property is well located close to a number of national occupiers and would suit any businesses looking to be well located in the busy Wigan Town Centre close to transport links.
