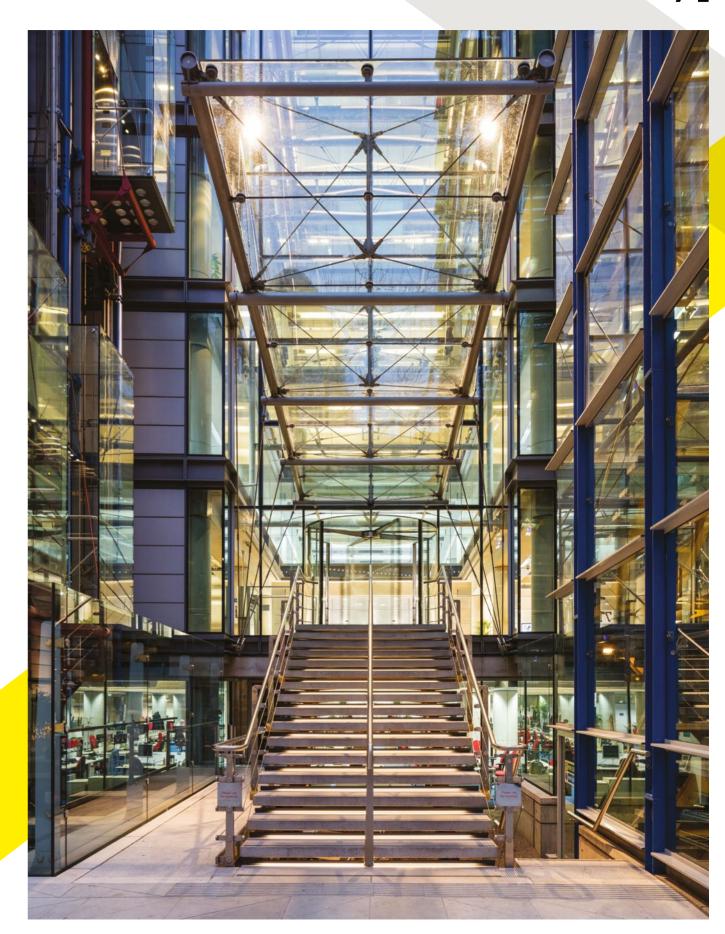

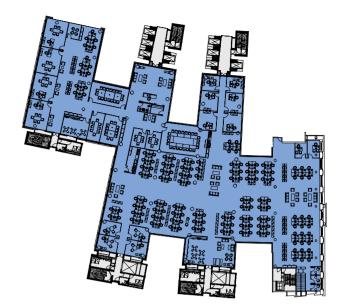

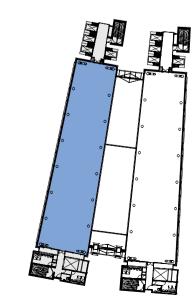

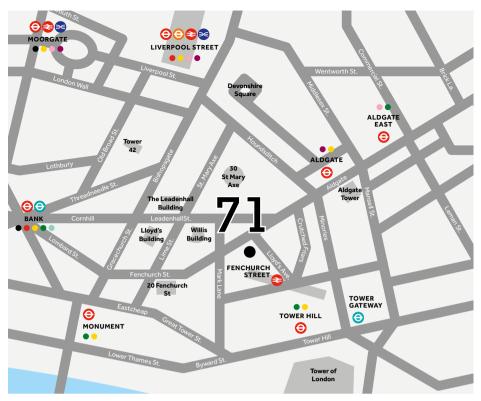

The building can be accessed via a re-landscaped private courtyard to the south of Fenchurch Street, the building is adjacent to Fenchurch Street mainline station and a few minutes walk from Lloyds.

In addition to Fenchurch Street, numerous other transport hubs are within a short walk; Tower Hill (Docklands Light Railway, District and Circle lines), Aldgate (Circle, Metropolitan and Hammersmith & City lines) and Liverpool Street (mainline, Central, Circle, Metropolitan and Hammersmith & City lines).
