

Location

The property is located fronting Hunters Road, Hockley.

Hunters Road connects directly to Hockley Circus and the A41 which is one of the main arterial routes running in and out of Birmingham City Centre.

Junction 6 of the M6 Motorway is approximately 2 miles distant and Birmingham City Centre is approximately 1 mile distant.

Description

The property comprises a multi storey brick built commercial building with access from Hunters Road.

The ground floor comprises of industrial/ workshop space being both heated and lit with level access loading onto Hunters Road.

The first floor is fitted out as predominantly open plan office accommodation which includes cellular meeting/ board rooms.

The offices benefit from raised access flooring, suspended ceiling with inset lighting, air conditioning and heating, WC and kitchenette facilities.

In addition, further space is provided at basement and second floor level.
