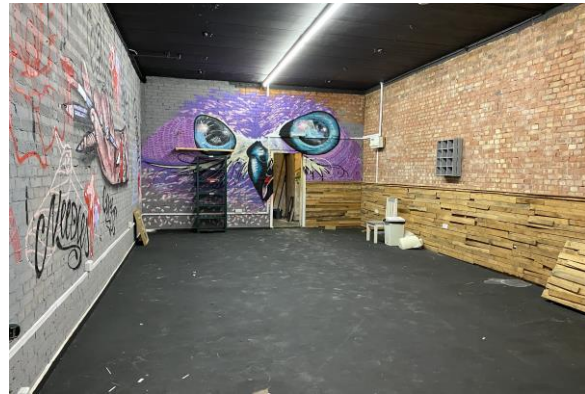

LOCATION
