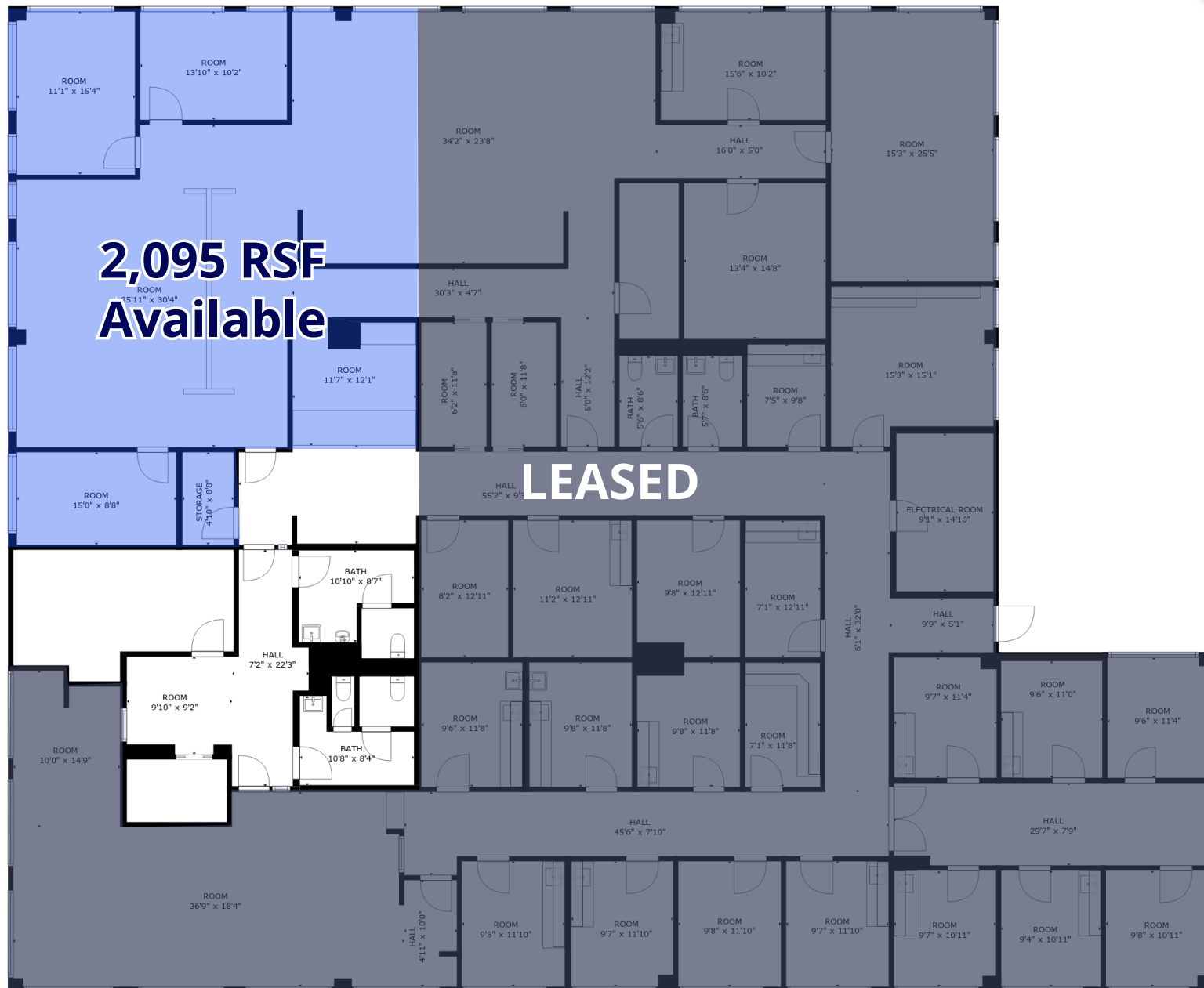


Floor plan Suite 300

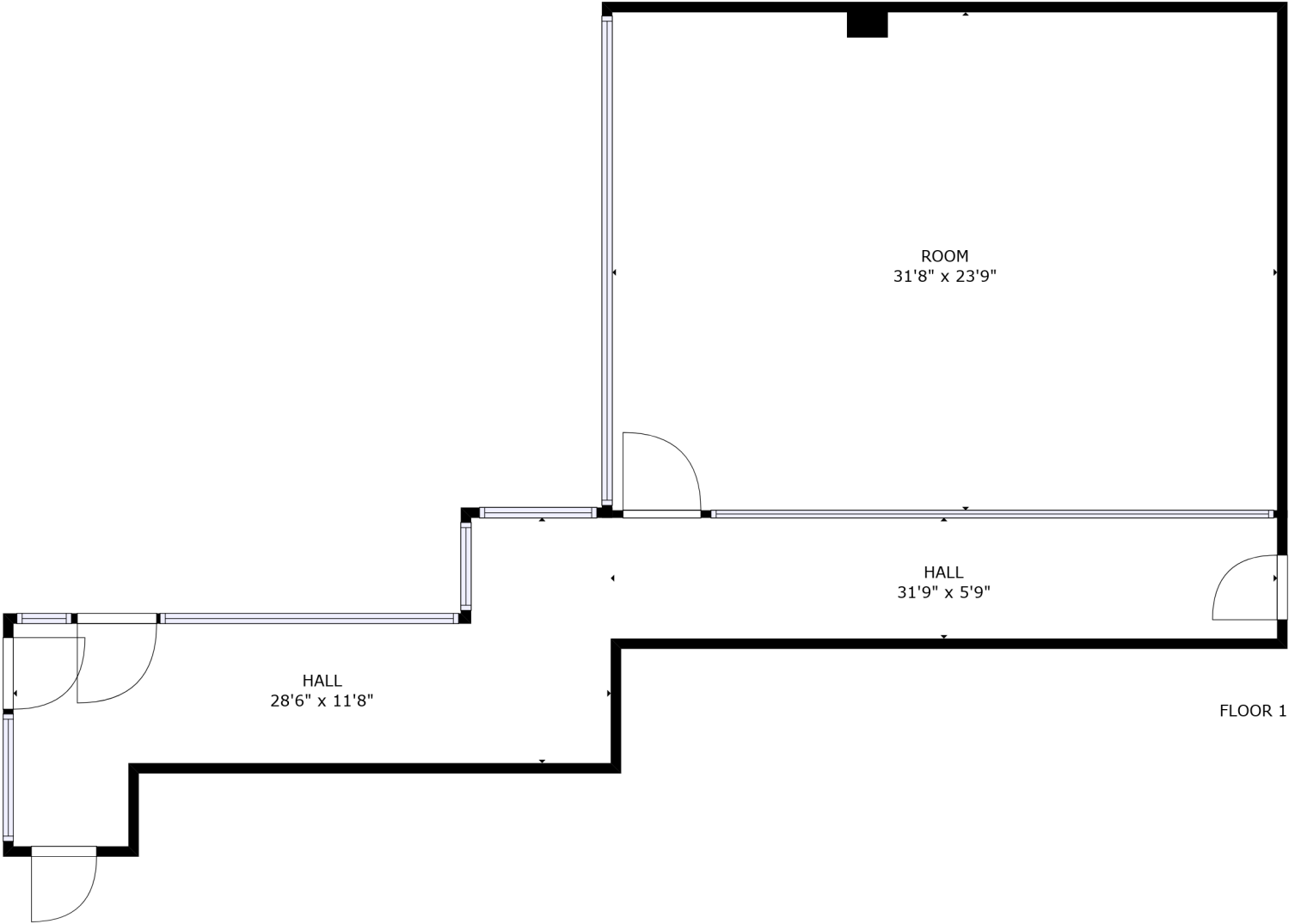


Floor plan Suite 200



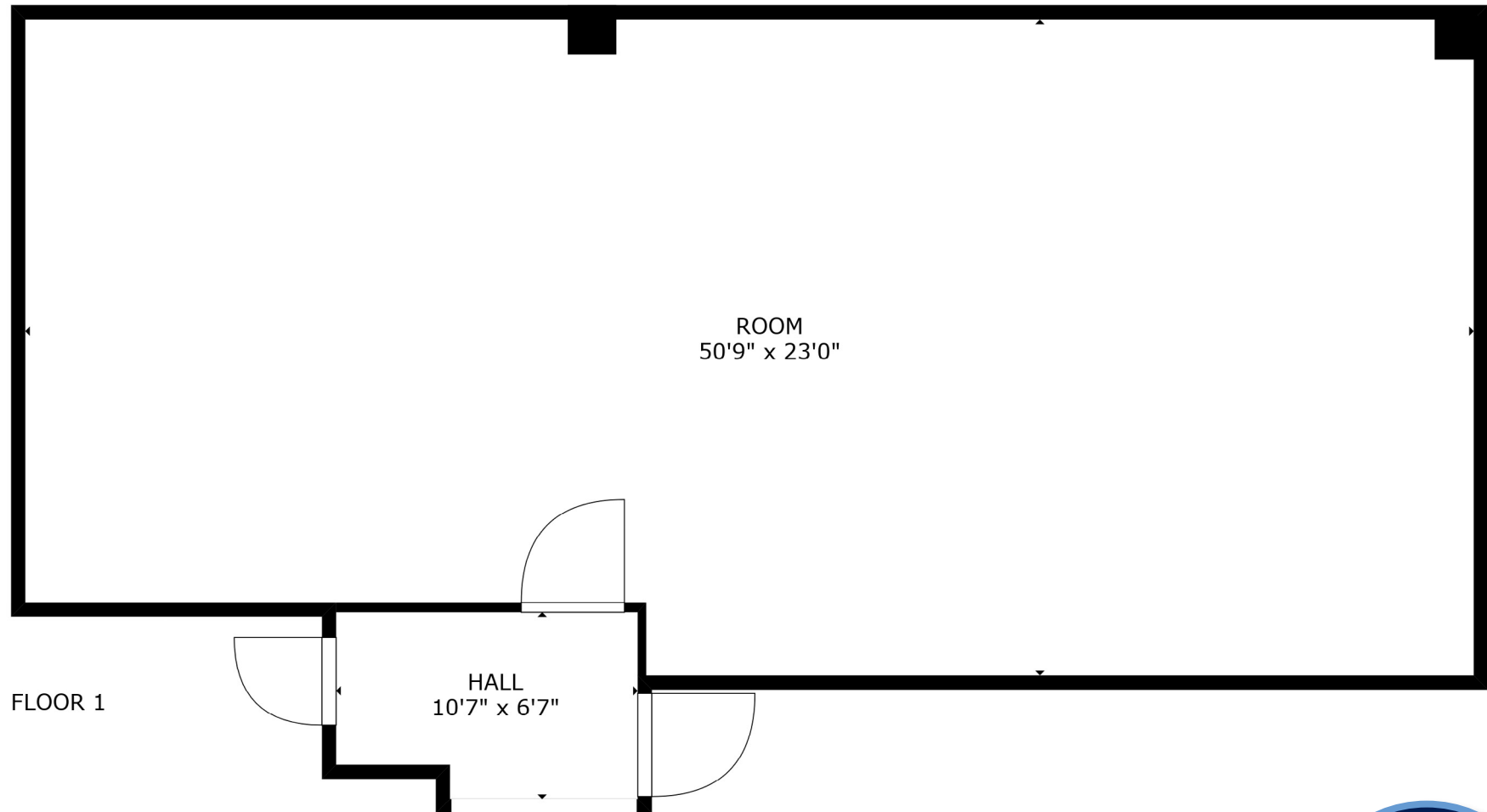
