#### Location

Westhill is situated approximately 6 miles West of Aberdeen City Centre and is widely recognised as a global centre of excellence for subsea engineering. The town has been subject to significant development in recent years with that trend set to continue.

Westhill Shopping Centre is located in the heart of the town with occupiers including M&S Foodhall, Greggs, Home Bargains, Lloyds Pharmacy and Costa. An Aldi Supermarket is also located towards the rear of the shopping centre. The shopping centre and office accommodation has provision for 314 customer car parking spaces.

#### Description

The accommodation comprises a bright and newly refurbished first floor office suite under a pitched and tiled roof. Access to the common areas is via an entrance fronting the car park. Refurbishment to the accommodation includes suspended ceiling, comfort cooling, central heating, new carpeting and repainted and decorated throughout.

In addition the entrance lobby, common corridors, ladies and gents WCs and common tea prepartion area have all undergone refurbishment.

### Floor Areas

The subjects have been measured in accordance with the IPMS3 RICS Code of Measuring Practice (First Edition 2015):-

First Floor 92.5 sq.m (996 sq.ft)

#### Lease Terms

The office suite is available on a new Full Repairing and Insuring lease term for a period to be agreed. Any longer term leases to incorporate periodic upwards only rent reviews.

#### Rent

£12,000 per annum.



### Service Charge

There is a development service charge payable by the tenant in relation to the maintenance, servicing and management of the common parts of the development. Details of the service charge figure are available from the leasing agent.

#### Rateable Value

The Valuation Roll shows a Rateable Value of £8,900.

If this is your only property, under the Small Business Bonus Scheme, an occupier may be eligible for 100% relief.
