The Prospect shopping centre is located in the heart of Hull City centre and comprises approximately 250,000 sq.ft. of retail space.

The covered centre boasts over 6 million visitors per year and has over 40 stores with retailers including Boots, WH Smith, Evans, Yours, Pep & Co, Clintons, Poundland and Game.

The scheme also benefits from a 250 space car park.


