Location

The Park Farm Shopping Centre provides the principle retailing destination for Allestree, a large residential suburb approximately 1 mile north of the city centre.

Allestree benefits from an affluent catchment with a residential population in excess of 60,000 within a 10 minutes drive time and is located close to the main University of Derby Campus, approximately 1 mile north of Derby City Centre.

Park Farm totals approximately 165,000 sq ft of retail space with anchor tenants such as Wilkinsons, Co-op Food Store, Boots, Farmfoods, Dominos and Papa Johns, along with a range of regional and independent retailers within 4 stores and 48 shops.

There is free customer parking on-site for approximately 400 cars and a centre manager on site.


