Location

The Park Farm Shopping Centre provides the principle retailing destination from Allestree, a large residential suburb approximately 1 mile north of the city centre.

Allestree benefits from an affluent catchment with the resident population in excess of 60,000 within a 10 minute drive time and is located close to the main University of Derby campus.

Park Farm totals approximately 165,000 sq ft of retail space with anchor tenants such as Wilkinsons, Co-op Food Store, Boots, Farmfoods, Dominos and Papa Johns, along with a range of regional and independent retailers within 4 stores and 48 shops.

There is free customer parking on-site for approximately 400 cars and a centre manager on-site.

Description

A self-contained ground floor retail unit, the property has double glazed aluminium framed shop frontage with a kitchen, male/female WCs, a small ancillary area and office to the rear with access to service yard for deliveries.
