

Location

Stretford Mall Shopping Centre is the principle shopping destination in the town and A56 corridor of south Manchester. The scheme provides over 340,000 sq ft of covered retail accommodation. The scheme benefits from an immediate catchment of 44,000 (Census:2001) with an annual footfall of approximately 6.7m visitors per year (Experian:2009).

The scheme is anchored by **Tesco**, **Wilkinson**, **Boots the Chemist** and **WH Smith** with other major retailers including **Iceland**, **Poundworld**, **New Look** and **Peacocks**.

The subject premises are one of the most prominent within the scheme being located in the very heart of the Centre with visibility to all malls. Neighbouring retailers include **Poundland**, **New Look**, **Specavers** and **Blue Inc.**

Accommodation

The premises have the following approximate net internal floor areas:-


