Location

Altrincham is located 9 miles south west of Manchester City Centre and forms part of the wealthy South Manchester commuter belt. The town has one of the most affluent catchment populations in the UK with an estimated shopping population of 59,000 and a catchment population of 82,000 (Promis). 65% of the catchment population are within the ABC1 subgroup.

Stamford Quarter is a £40m redevelopment of the town's primary shopping area amounting to over 300,000 sq ft of modern retail and leisure accommodation. The Centre is anchored by H&M, New Look, Next, River Island, Waterstones and Desire by Debenhams.

Stamford New Road is located opposite the train station with occupiers including Nando's Pure Gym and only one unit now remains in this popular location.


