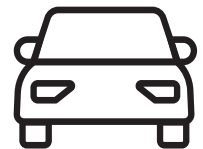

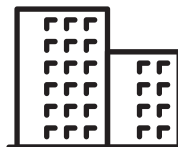

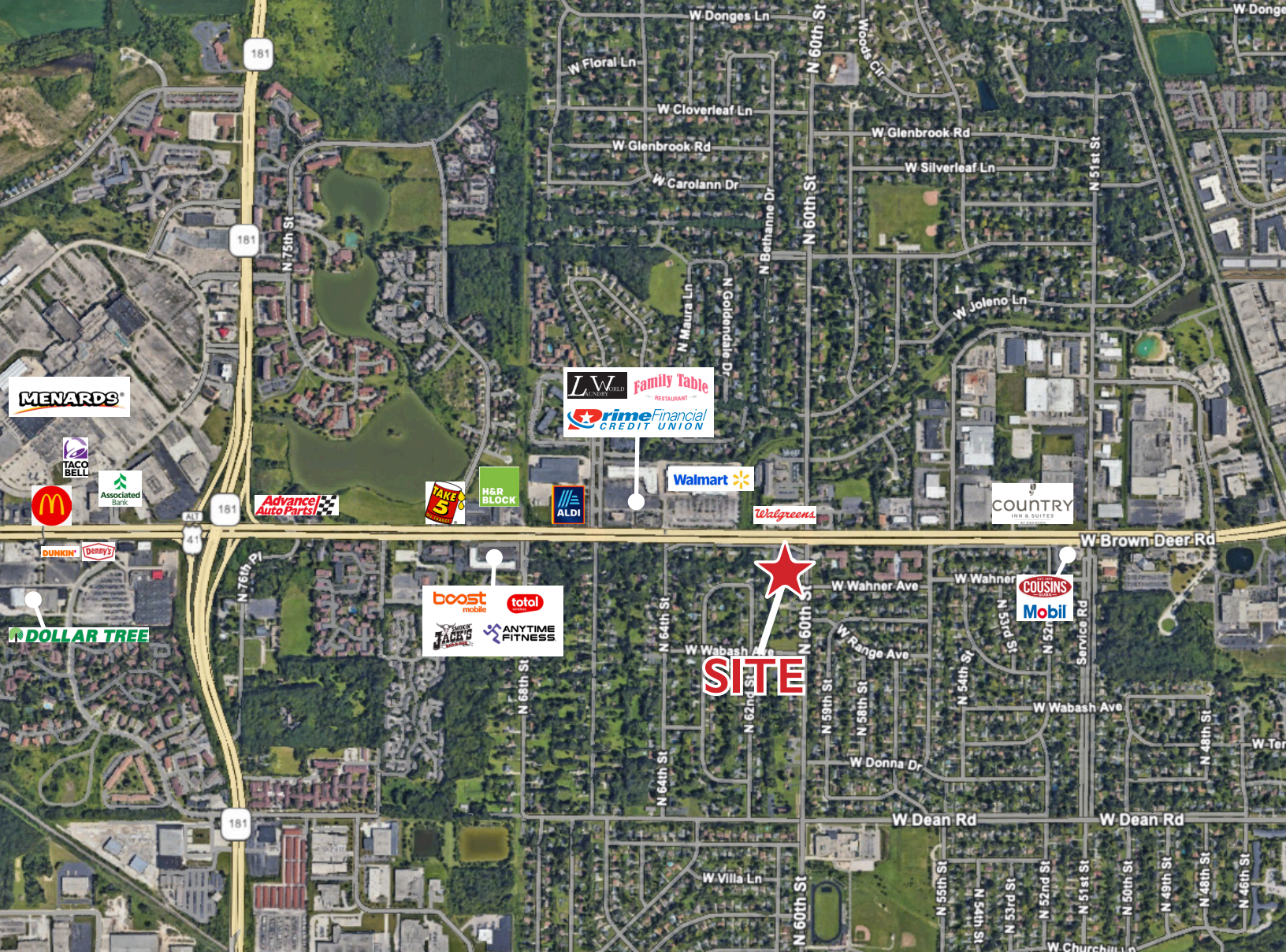

# STATE OF WISCONSIN | DISCLOSURE TO CUSTOMERS
