Location

Stretford Mall Shopping Centre is the principle shopping destination in the town and A56 corridor of South Manchester. The scheme provides over 340,000 sq ft of covered retail accommodation. The scheme benefits from an immediate catchment of 44,000 with the most recent annual footfall of approximately 6.7 million visitors per year.

The scheme is anchored by Aldi, Tesco and TJ Hughes, with other major retailers including Peacocks, Poundland, Iceland and WHSmiths.

The subject premises are situated in an excellent location on Broady Street Mall at the main entrance to the scheme off the busy surface car park in close proximity to the new Aldi and Costa stores.


