Location

The property is located within a terraced parade of retail units in the residential area of Northfield in the city of Aberdeen. Northfield is 3.5 miles north of the city centre.

Description

The property comprises a ground floor retail unit with Class 3 Consent within a terrace of shops being of blockwork construction and having a flat felt covered roof.
