# Location

The unit is situated within St Vincents Trading Estate, enjoying a highly prominent position fronting Feeder Road, a popular destination for trade occupiers. Bristol City Centre is approximately 1.5 miles west and access to the M32 can be gained via St Philips Causeway, approximately 4 miles away. In addition Temple Meads train station is located within close proximity, to the west of the property.

# **Description**

Unit H is an end terrace unit of steel truss frame construction with brick/block elevations and steel profile cladding above. The pitched roof benefits from 10% natural roof lights, whilst the property has an eaves height of 5.80m. The property benefits from ground floor office accommodation internally.

An electric roller shutter door provides access into the unit, whilst the secure yard is accessed via a separate electric loading door to the rear. Externally the property benefits from 28 demised car parking spaces to the front.
