The Cascades, is the predominant shopping centre in Portsmouth City Centre, anchored by Primark, H&M and Next. On average the centre receives 192,000 visitors per week, served by in excess of 1,000 adjacent car parking spaces.

The shop is currently occupied by **Menkind** and is in a prime position boasting an extensive return frontage facing Lush, adjacent to USC and opposite H&M and Pandora. Other nearby retailers include Primark, Body Shop, Goldsmiths and New Look Men.


