

# **Opportunity**

Our available sites, warehousing and office accommodation are situated within the secure confines of the Port of Barry, which has excellent multimodal connections, via the A4231 link road to Junction 33 of the M4 in addition to direct rail connections to the Barry Intermodal Terminal, enabling container transportation by train to UK deep sea hub ports.

The Port of Barry is a key facility for the region's chemical industry, handling liquid bulks for major companies including Dow Corning. Barry also has considerable expertise in the handling of steel, scrap metal, containers, dry bulks, coal, and aggregates. The Port also has significant development opportunities available for the design and construction of bespoke business space.

### Location

The Port of Barry has direct access to the M4 at Junction 33, via the A4231 / A4050, which in turn links to the A4232 and onto the M4, 9 miles to the north. Cardiff is situated 9 miles to the east and Cardiff Airport just 6 miles to the west. There are direct rail services from the Port to Cardiff. The main entrance to the Port is accessed off Wimborne Road, which links directly to Ffordd Y Mileniwm.

Road M4 J33 – 14.5km / 9 miles Cardiff – 14.5km / 9 miles Bridgend – 32.2km / 20 miles Port Talbot – 54.7km / 34 miles

**Rail** Direct rail access available from the Port. Handling services can be provided.

Air Cardiff Airport – 9.7 km / 6 miles Bristol Airport – 96.6 km / 60 miles

**Sea** Direct access to quayside capable of taking vessels of 23,000 dwt.

## Port Services

The docks accept vessels of varying sizes (beam: up to 19.2m, draught: up to 9m, length: up to 178m, DWT: 23,000 tonnes). The Port benefits from cranage, mechanical handling equipment and weighbridge facilities, together with coveraged and outside storage facilities for steel cargoes as well as a recycled metal import / export terminal with dedicated a rail connection. The Barry Intermodal Rail Terminal facilitates container transportation by rail to UK deepsea hub ports. ABP can provide handling services (quotation on application).
