LOCATION

The site is situated just off Moseley Road approximately one mile from Burnley Town Centre and all its amenities.

This is a secluded and popular location being surrounded by good quality detached properties.

DESCRIPTION

A generally level plot accessed directly off Timberhill Road.

The site has been used as a ménage for many years. Adjacent to the site is a small piece of land that will be included in the sale.

SERVICES

The vendors have paid for the mains water connection to the site to all 5 plots at £18,200. Further mains electricity has been provided at a cost of £42,000. There is no gas in the area. A septic tank (treatment plant) will need to be provided for foul drainage.

PLANNING

Planning permission was granted for four dwellings application number APP/2013/0367 in June 2017. Planning for the fifth dwelling was granted on 30th April 2019 App/2019/0054




