Apex Court is an established purpose-built office campus in Almondsbury benefitting from excellent road links, junction 16 of the M5 motorway being just 1 mile distant, giving direct access to the M4/M5 Motorway interchange. Bristol Parkway railway station lies within 3 miles and the M32 Motorway provides swift access to Bristol city centre.

#### **Description**

21 Apex Court is a semi-detached 3 storey office building with surface level parking. Internally, the accommodation has been recently upgraded and is offered in excellent condition with the benefit of a very attractive fitout. The specification includes:
