LOCATION

DESCRIPTION

The ground floor unit comprises a regular shaped lock-up unit with a fully glazed front elevation. There is a WC and storage space to the rear of the unit, with an access door leading to the service road.

There is ancillary storage space located on the upper floor of the property. Access to the first floor of the property is via an external metal staircase leading from the service road.
