Description

The premises comprise a mid terrace industrial unit of steel portal frame construction under a single pitched roof (incorporating industrial rooflights) with profile metal sheet cladding and lower level brick blockwork. Internally, the warehousing is served to a single roller shutter loading door to approximately 4m height and a single pedestrian door.

The warehouse has an amenity block to the front of the unit incorporating male/female WC facilities together with a separate sink and kitchenette. Heating is via a wall mounted hot air blower. The internal eaves height is approximately 6m.

The unit extends to a gross internal area of approximately 4,500 sq ft (418 sq m).
