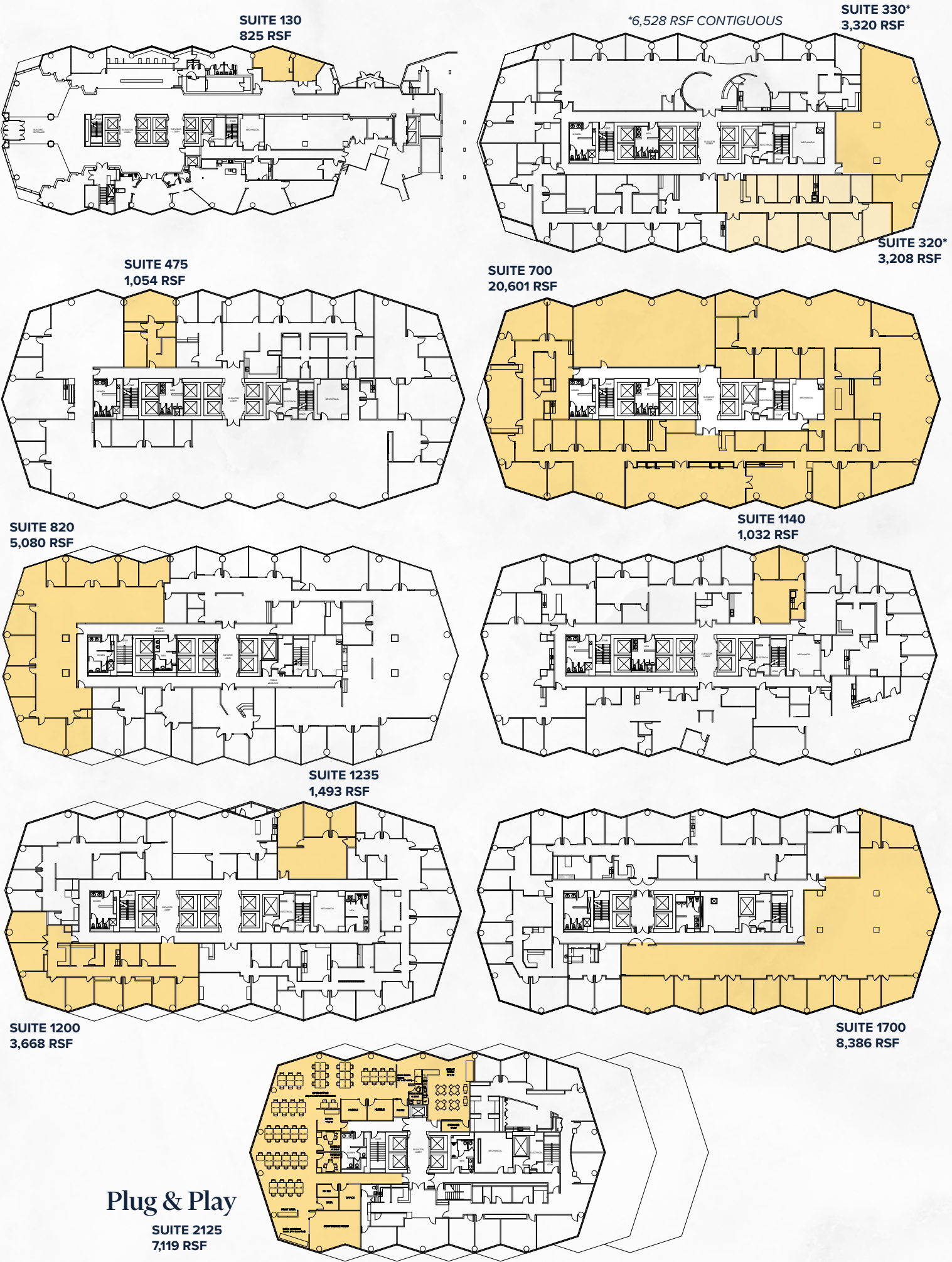

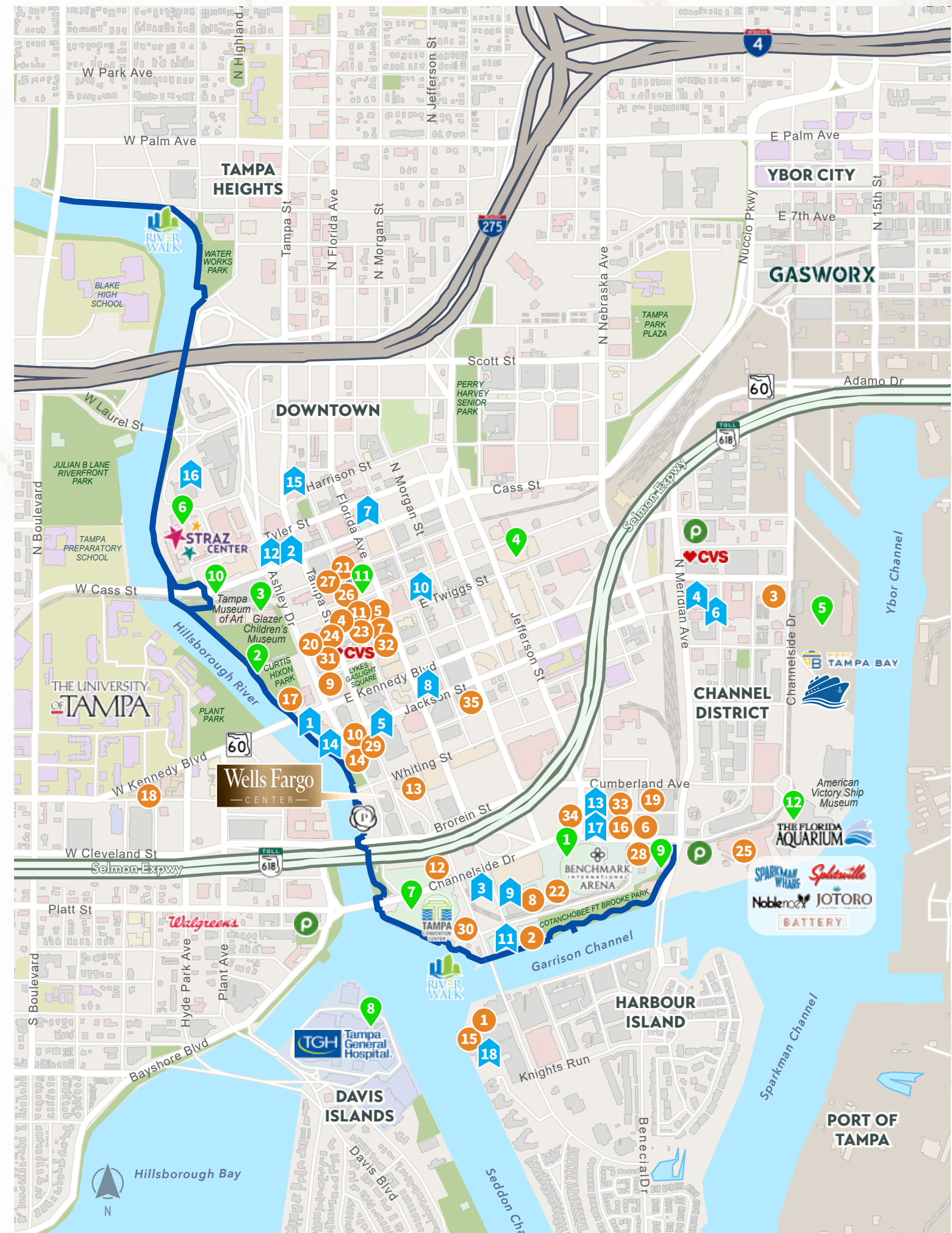


PENDRY
