### LOCATION



Taunton is the administrative and economic centre of Somerset and is situated beside the M5. It has a district population of 110,000. The town is one of the fastest growing locations in the South West with the population planned to increase by 25% to 2028. 'Garden Town' status was awarded in 2017 to further stimulate growth and improvement. Taunton has good communications with Junction 25 of the M5 located 2 miles to the east of the centre. Taunton Rail Station provides regular services to London, Bristol and Exeter with a typical journey time to the capital of 1 hour 50 minutes. Hammet Street is located within the heart of the town and comprises mainly period buildings converted to office accommodation. Nearby occupiers include solicitors, surveyors and estate agents.

### DESCRIPTION

14 Hammet Street comprises a Grade II \* Listed Building. The accommodation is accessed via an internal staircase from Hammet Street and comprises first and second floor period style accommodation with good natural light and requiring refurbishment.
