The premises are situated within Kings Square which is a covered shopping centre and home to the town's market. **The Centre has an average footfall in excess of 120,000 per week.**

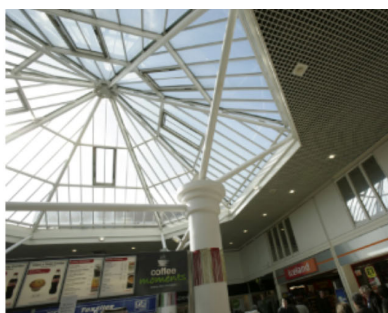
