

#### Location


Situated approximately 6 miles west of Edinburgh City Centre, Granton is located within the heart of the Edinburgh Waterfront development which extends for some 140 hectares (345 acres) and over 3km of water frontage overlooking the Firth of Forth estuary.

Nearby occupiers include Morrisons food store, Pure Gym and Telford College which caters for 20,000 students and 600 staff.

### Description

The subjects form part of a new build Local Centre developed by Wm Morrison Supermarkets which comprises a 77,000 sqft Morrisons store with 520 parking spaces and additional retail, office, restaurant and student accommodation.

The subjects comprise accommodation over ground and first floors. The unit, with curved glazed frontage, benefits from a stunning view of the Forth estuary. The subjects will be provided in shell condition with service pick ups for the ingoing tenant to fit-out.
