



## **GENERAL COMMENTS**

The land is situated to the south of Main Road, Barnoldby le Beck. We calculate (using Promap) that the total site area, including access road, is approx. 0.6 hectares (1.5 acres). Barnoldby le Beck is a popular and exclusive village situated  $5\frac{1}{2}$  miles to the south west of Grimsby town centre and is home to around 230 people. The village is readily accessible to the A18 which in turn provides access to the national motorway network at Barnetby Top. The village has some of the highest house prices in the wider North East Lincolnshire Council area.

The available land is accessed from Main Road with the access being adjacent to The Georgian House. The land has a maximum width of approx. 145m (475ft) and a maximum depth of approx. 35m (115ft). The site is surrounded by high quality residential dwellings offering future development potential. Interested parties are advised to make their own enquiries of the Local Planning Authority.

**PRICE** The land is being offered for sale on an unconditional basis for £150,000.
