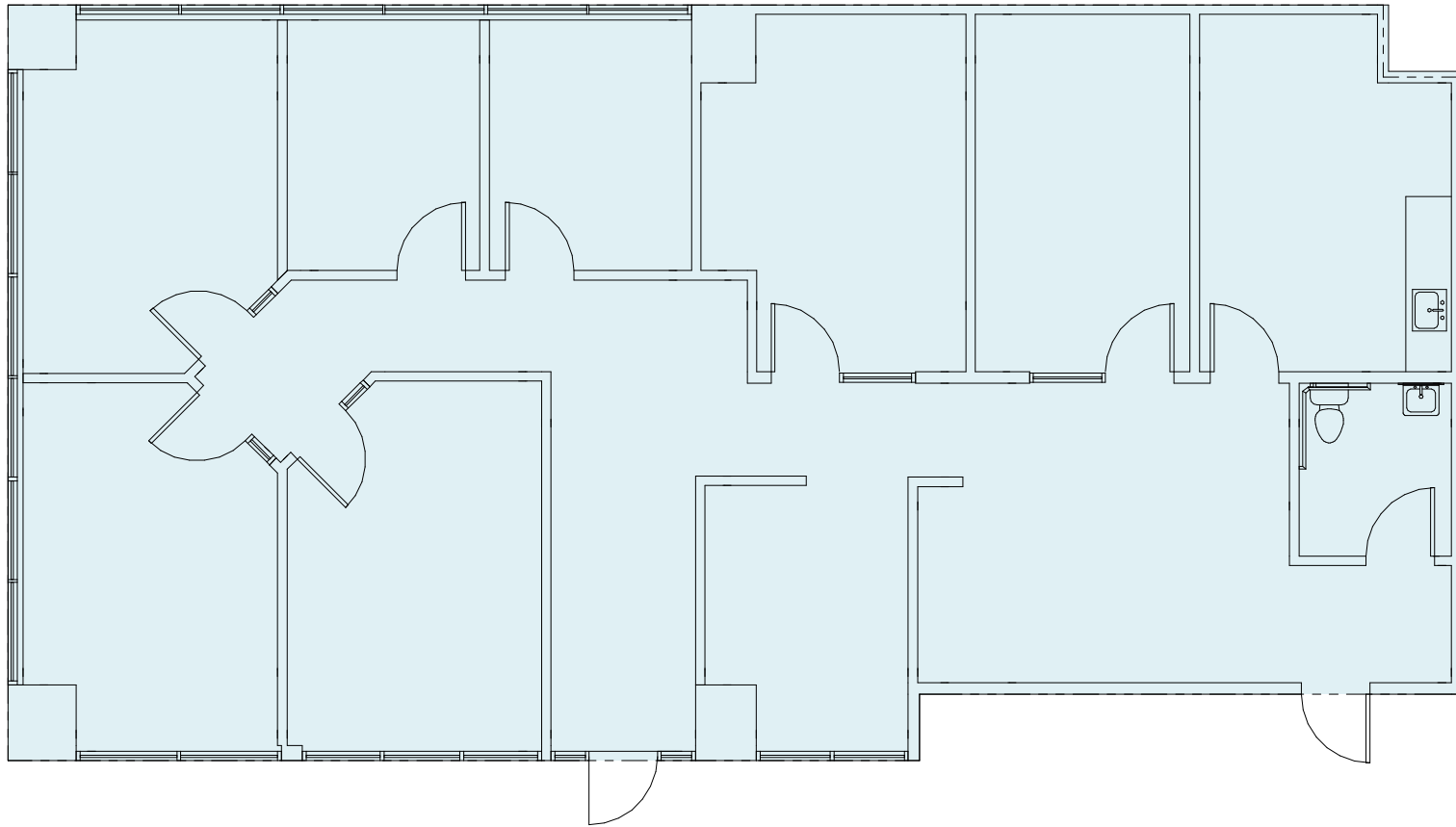

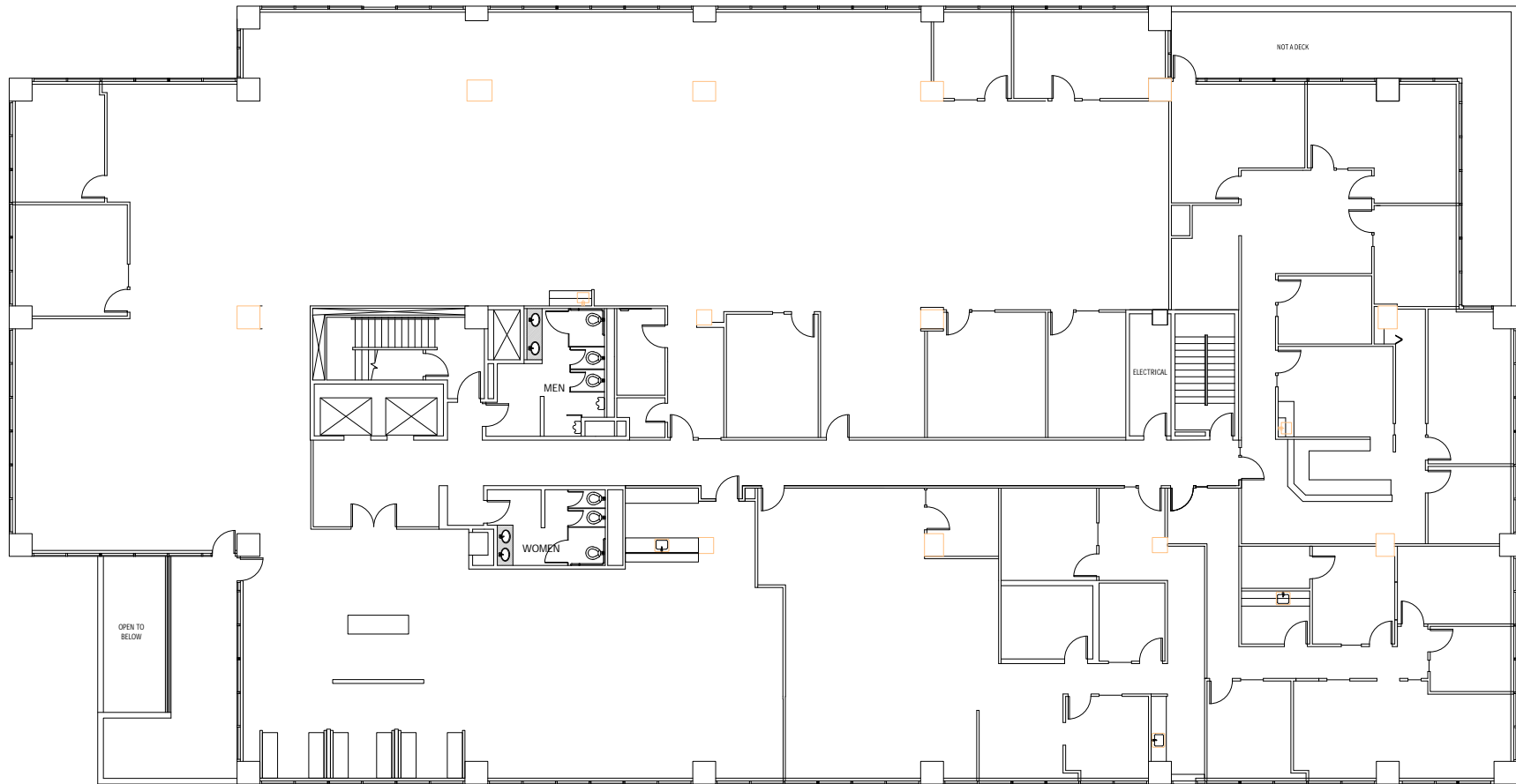


FLOOR PLAN - SUITE 7
