Location

The Vernon Gate development is located within the Friar Gate Conservation Area and popular commercial and professional district on the edge of city centre, close to the ring roads and A38/A52 network. The development offers modern offices within a Georgian style courtyard behind the Grade II Listed Façade of the former 19th Century County Gaol.

Description

The property is a mid-terraced three storey office building of steel frame construction with blockwork walls under a pitched slate roof with brick clad elevations and softwood double glazed windows.

The first floor has been redecorated and recarpeted throughout and will be split to provide 3 suites ranting from 738 to 1,006 sq ft and could be made available separately or combined.

The layout is predominantly open plan with some partitioned offices, which could be removed or reconfigured if required. The suite benefits from suspended ceiling with Category 2 lighting, perimeter data trunking and w.c. facilities.
