EVENTS, TRAINING, SCHOOLS, & MORE

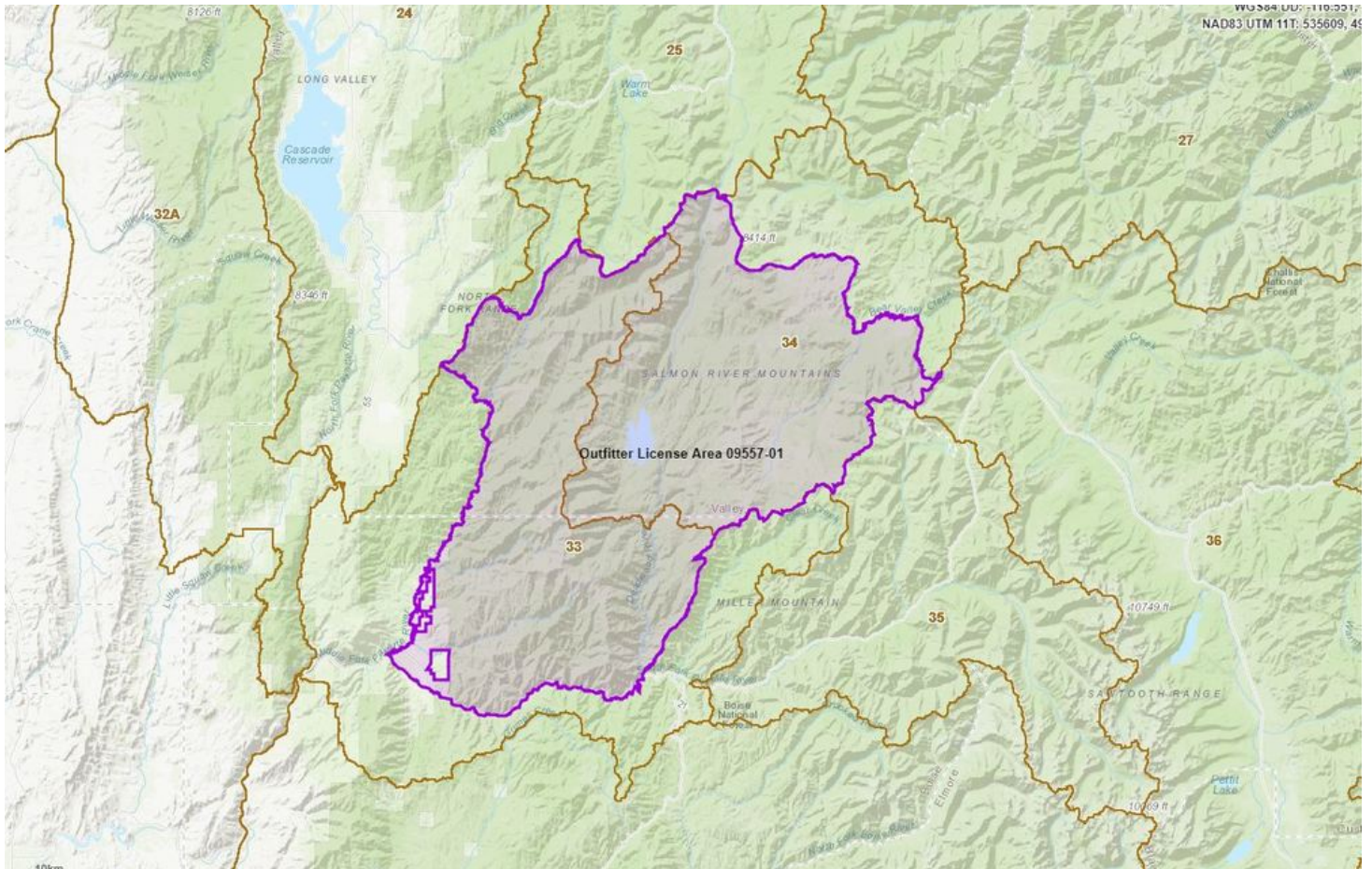

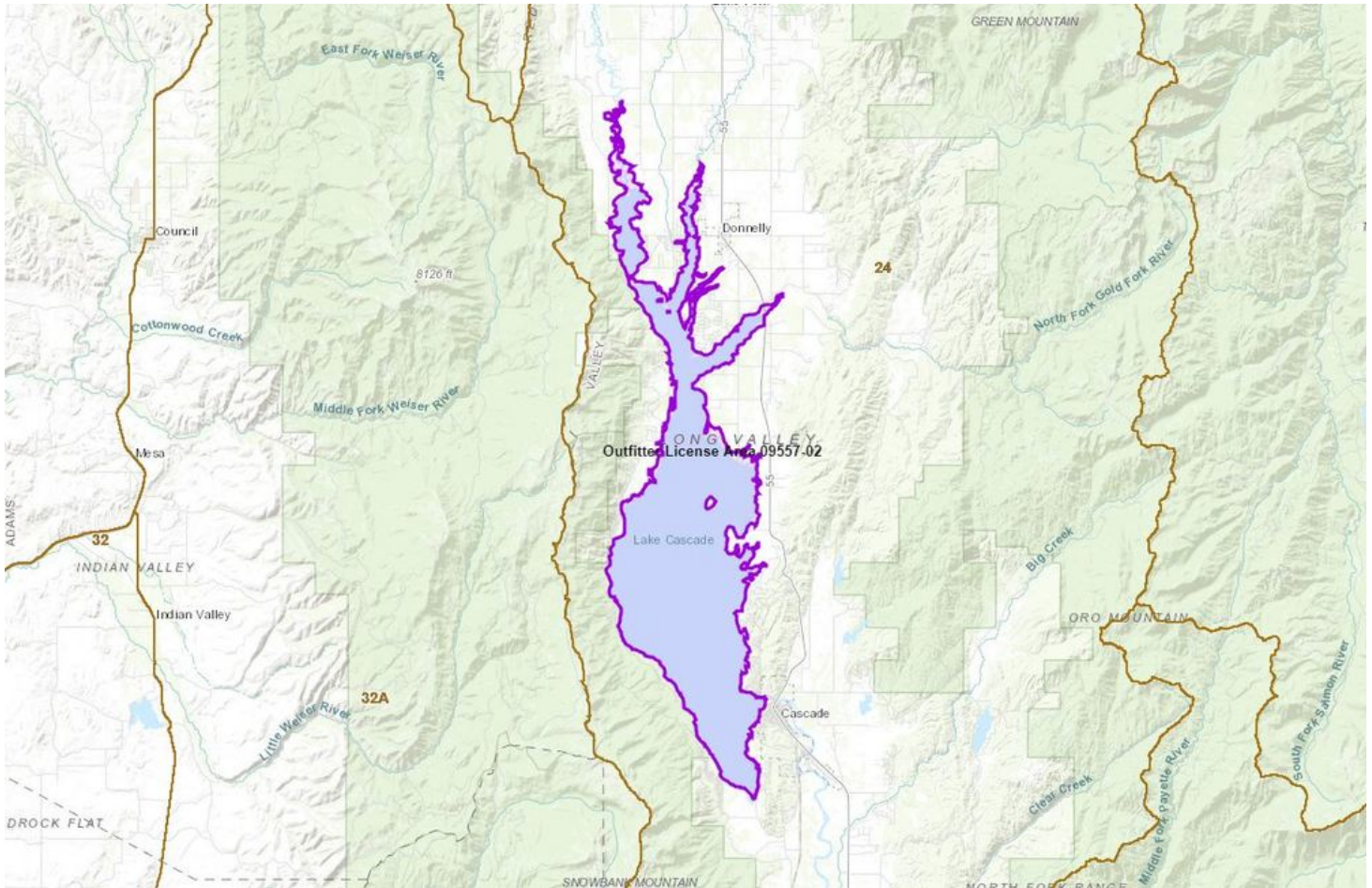

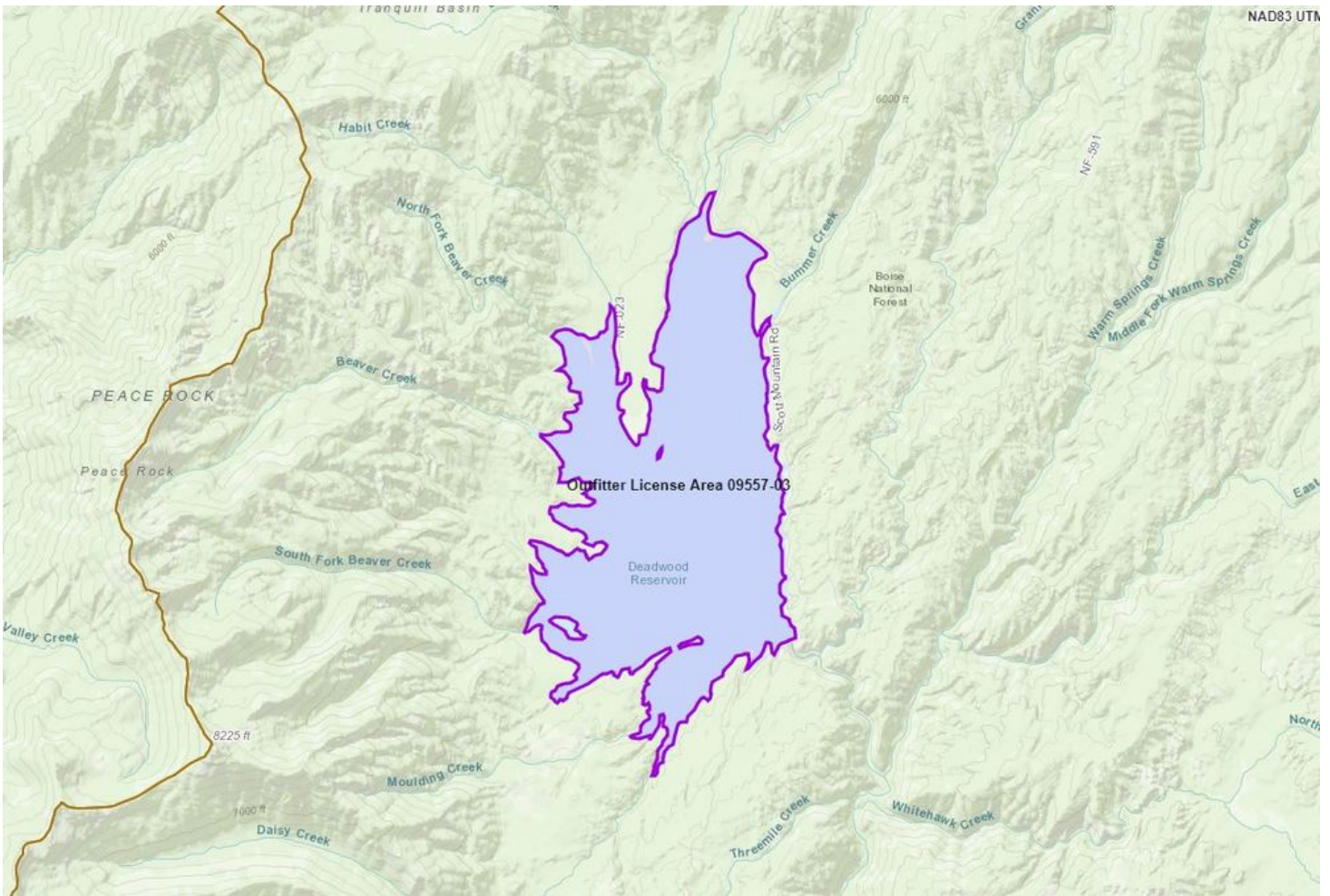
LICENSE AREA 1 (Deer, Elk, Moose, And More)
