LOCATION

Leigh on Sea is an affluent town in the district of Southend on Sea in Essex. It has a population of circa 22,509 (2011 Census) and is a popular commuter town. There is a frequent direct train to London Fenchurch Street that takes under an hour as well as links to Southend on Sea. The property occupies a prominent position on Rectory Grove close to the prime retail pitch of the Broadway. There are a mixture of independent retailers nearby including a dry cleaners, interior design shop and opticians.

DESCRIPTION

The property is arranged over the ground floor of Baryta Court with residential apartments over the two upper floors. The property is divided into two units: 24-28 Rectory Grove and 30 Rectory Grove. Three lock up garages form part of the demise to the rear of the building.
