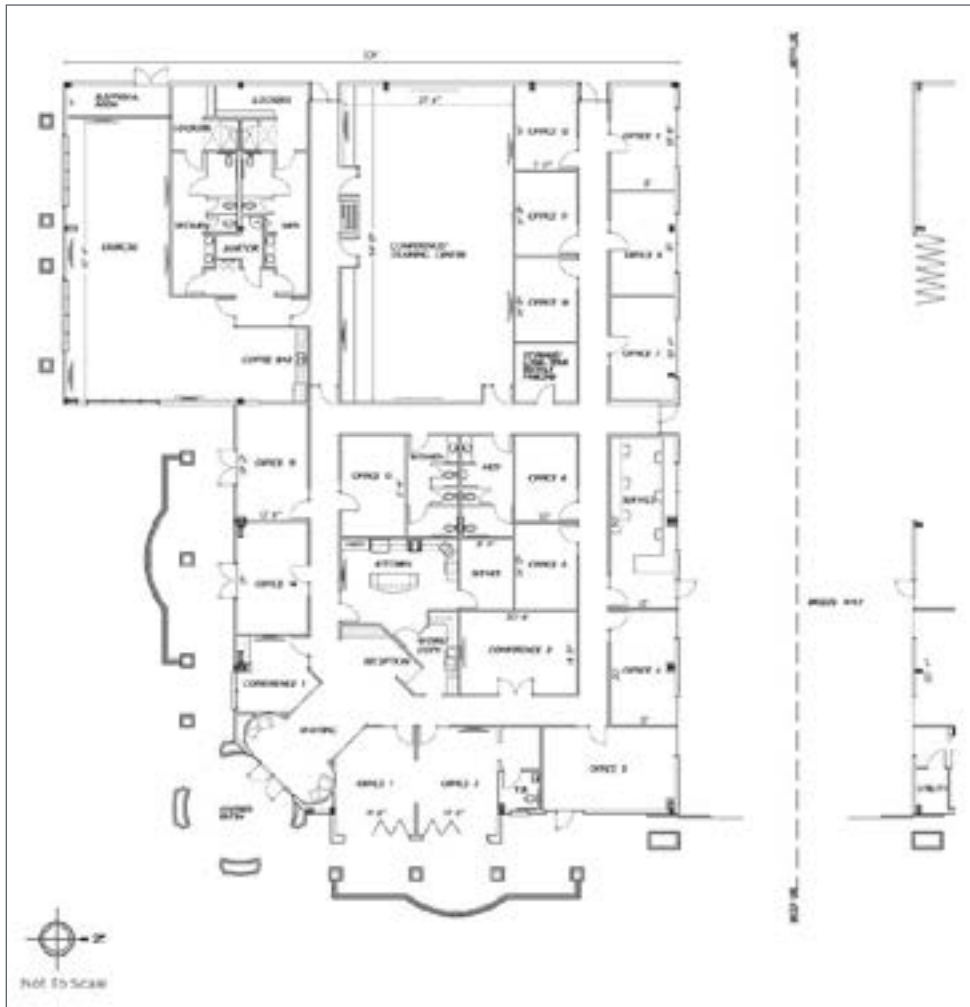

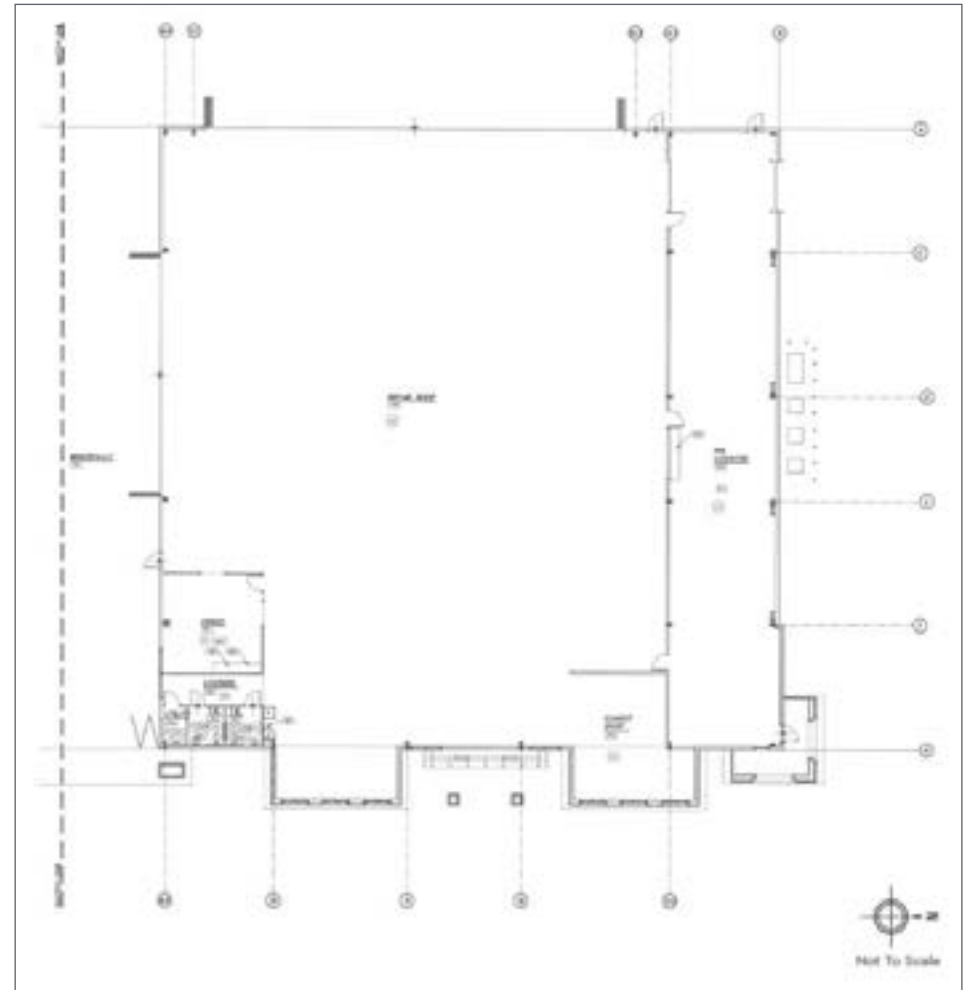

Building 1



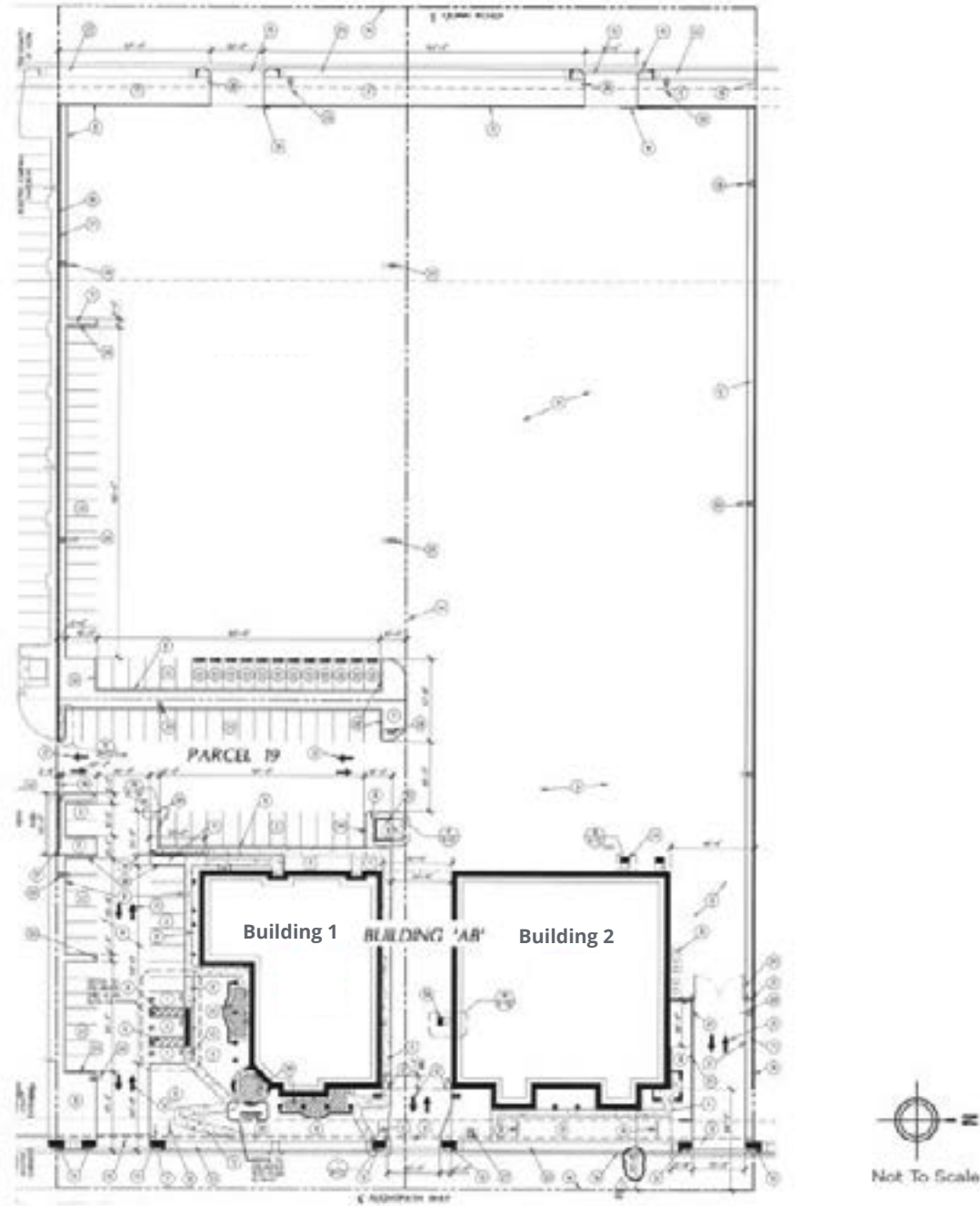

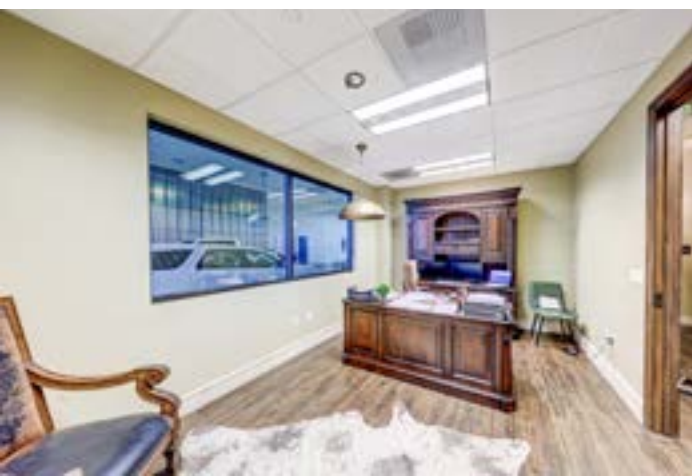
Site Plan
