#### Location

Uppingham is a small market town in Rutland situated approximately 20 miles west of Peterborough, 20 miles east of Leicester and 30 miles north of Northampton. The town has a retail centre based on High Street which is split to the East and West by the A6003. High Street East is the principle retail pitch where occupiers are generally local traders together with **Boots**, **McColl's** and a **Co-op Supermarket**. 
