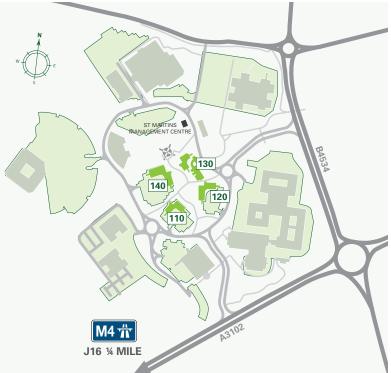
It is home to many national and international companies including RWE npower, Nationwide Building Society, Arval and Cable & Wireless.
