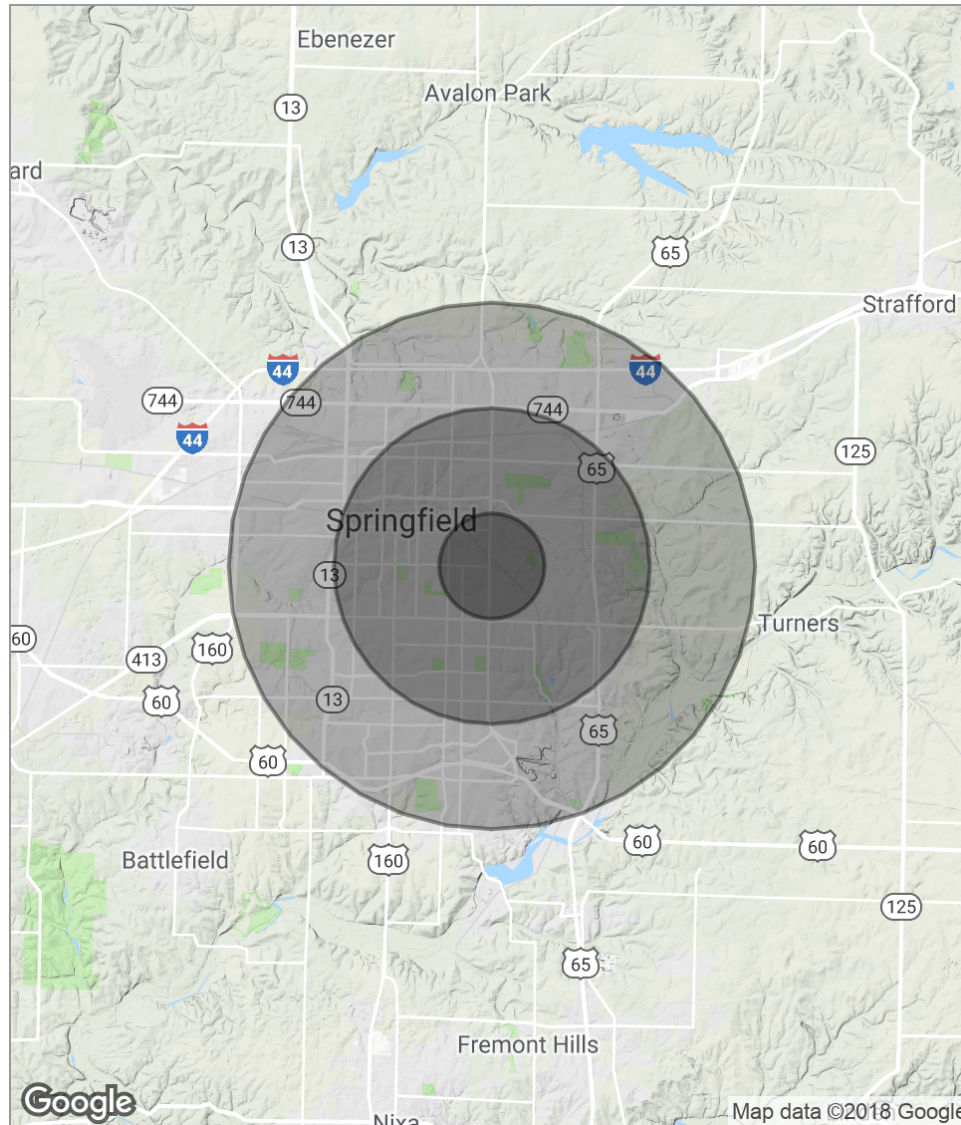
Map
