Location

Omagh is one of the strongest provincial retailing locations within Northern Ireland. It is the major administration centre for County Tyrone, with a catchment population of approx. 100,000 people.

Showgrounds Shopping Park provides the towns main shopping facilities and occupies an edge of town centre pivotal location. Occupiers include M&S, Next, River Island, Sports Direct, Laura Ashley, New Look, Tempest, Argos and Peacocks. Work is underway for the first standalone Greggs unit in the province opposite M&S.

The scheme is within walking distance of the town centre and has the benefit of 368 free car parking spaces.

The subject unit occupies a prime position flanked by River Island and Sports Direct.


