Location

The unit is located within The Boxworks, a well-established site primarily of light industrial use. The site is well located, being just 0.4 miles from Dunnings Bridge Road, leading to Switch Island with access to M57 & M58 and wider national motorway networks. The Boxworks is just 2.7 miles from Seaforth Port, and only 6 miles from Liverpool City Centre. The unit is well connected with Old Roan Train Station being just a 15 minute walk from the site.

The Boxworks provides a number of self-contained light industrial/trade units. Unit 8A is situated within the main building, which provides a secure unit serviced by a 3-phase electricity supply, and accessed by an electric roller shutter door. The premises provides a main warehouse including breeze block constructed office accommodation situated to the rear, with a mezzanine storage level above.
