Location

The route to Heathrow taking less than 26 minutes is to be launched in 2022. In addition, to four tube lines (Bakerloo, Hammersmith & City, Circle and District) and Paddington Main Line, this has made the regeneration of Paddington Basin a success with its restaurants, bars and boutiques dotted along the canal as far as Little Venice.
