Location

The Orbital One Trading Estate is located on Green Street Green Road accessed off Princes Road (A225) and within half a mile of junction 1b M25. Access to Princes Road from the south (anti-clockwise) is via junction 2 (A2-M25 interchange) and from the north (clockwise) is via junction 1b. The estate is situated a mile from Dartford town centre and Bluewater Shopping Centre is 3.5 miles to the east.

Unit 1 is a modern detached industrial / warehouse unit constructed around a steel portal frame with profile clad elevations and partially glazed frontage incorporating two roller shutter access doors.
