Location

Stockton on Tees is located approximately 4 miles west of Middlesbrough and 12 miles north east east of Darlington, forming part of the Teesside conurbation. It is estimated that there is a population of 350,000 within a 15 minute drive time (Source; Illumine)

Castlegate Shopping Centre is the principal shopping location in the town with key retailers including Wilkinson, Boots, Iceland, Peacocks, Home Bargains and the towns' indoor Market, which has recently undergone refurbishment.

The subject property is situated adjacent to the entrance into the busy Spencer Market Hall, fronting the High Street in close proximity to Brighthouse, Specsavers and Boots


