The premises comprises of a former bingo hall and cinema, situation in the upper floors of a substantial detached four storey building. The accommodation can be accessed via a self-contained ground floor entrance and would be suitable for a variety of uses, subject to necessary consent. To the exterior of the ground floor is a shared car parking area, providing car parking for approximately 25 cars.


