Area

Bedlington is a former mining town in south-east Northumberland. The area is predominantly residential with numerous schools and healthcare facilities in the locality. Further amenities are found in the town centre which is currently undergoing a major mixed-use redevelopment scheme. The highly funded project will create a number of jobs for local residents as well as enhancing the commercial offering and image of the town.
