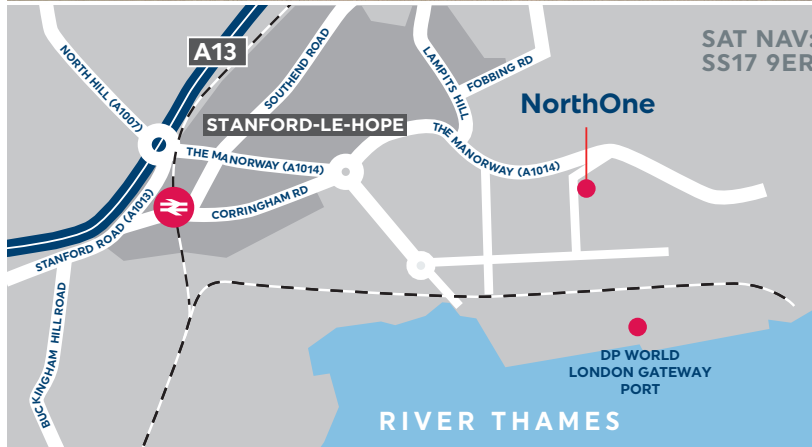
Location and description
