Location

The property is located on Tower Bridge Road in a prime location, 200m south from Tower Bridge in Southbank. The site is a 10 minute walk away from London Bridge Station. The former bank is Grade II listed and was built in c. 1900.The four storey building occupies a prominent corner position, with the main entrance to the building located on the corner of Tower Bridge Road and Tooley Street.
