

EXECUTIVE SUMMARY

Newmark Grubb Zimmer (NGZ) Capital Markets, as exclusive advisor, is pleased to present the opportunity to acquire Plaza Hill Manor, a 162-unit multifamily complex located at 3712 E 47th Terrace in Kansas City, Missouri. Plaza Hill Manor recently underwent a transformative renovation providing residents with some of the best workforce housing in the Kansas City MSA.

Plaza Hill Manor is composed of 162 units consisting of 6 studio units averaging 416 square feet, 150 one-bedroom one-bath units averaging 488 square feet and 6 two-bedroom one-bath units averaging 710 square feet. The property consists of 10 masonry-style buildings and encompasses 5.32 acres. Originally built in 1950 the buildings are two stories with pitched roofs (composition shingle) and vinyl windows with dual-pane glass. The common area amenities consist of six laundry facilities on site.

The property recently underwent a \$2.5 million-dollar renovation with major improvements to the interiors and exteriors of the buildings. The upgrades include new roofs, new gutters and soffits, HVAC units, new hot water heaters, and new flooring. The kitchens have been upgraded with cabinets, countertops, and new appliances.

The property sits just off Emanuel Cleaver Boulevard, a major thoroughfare with access to shopping, dining, and entertainment. Plaza Hill Manor offers a great location just 2 miles from The Country Club Plaza and 8 minutes from the University of Missouri - Kansas City, Rockhurst University and the Kansas City Art Institute. Shopping, schools, banking, restaurants and entertainment are right around the corner with convenient access to the Shops on Blue Parkway.

Plaza Hill Manor has been completely repositioned in the marketplace. After acquiring the property ownership reduced occupancy to begin renovations. Over the past 24 months the property has been completely re-tenanted.

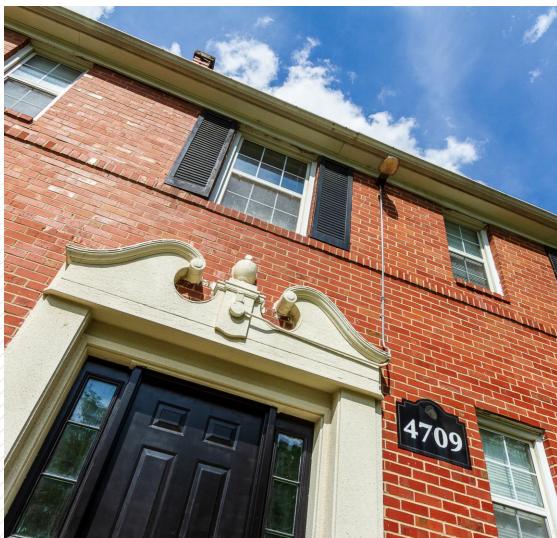
