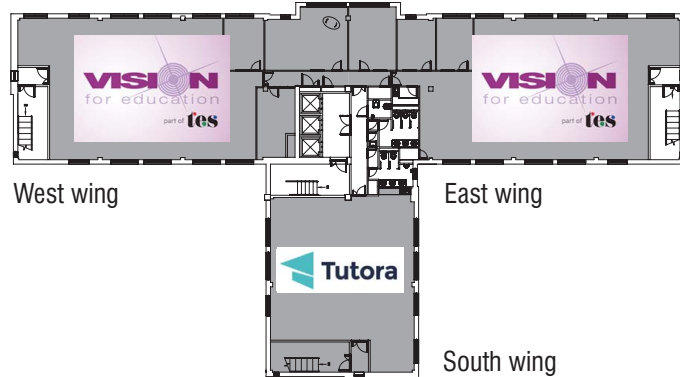
The Building

With space ranging from 1,939 - 8,892 sq ft, Concept House provides exactly the amount of space your business needs.

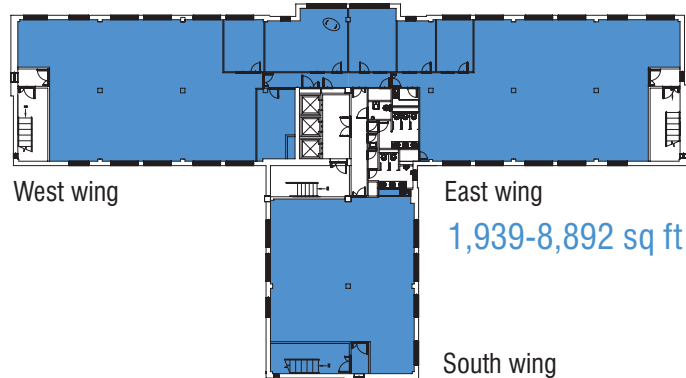

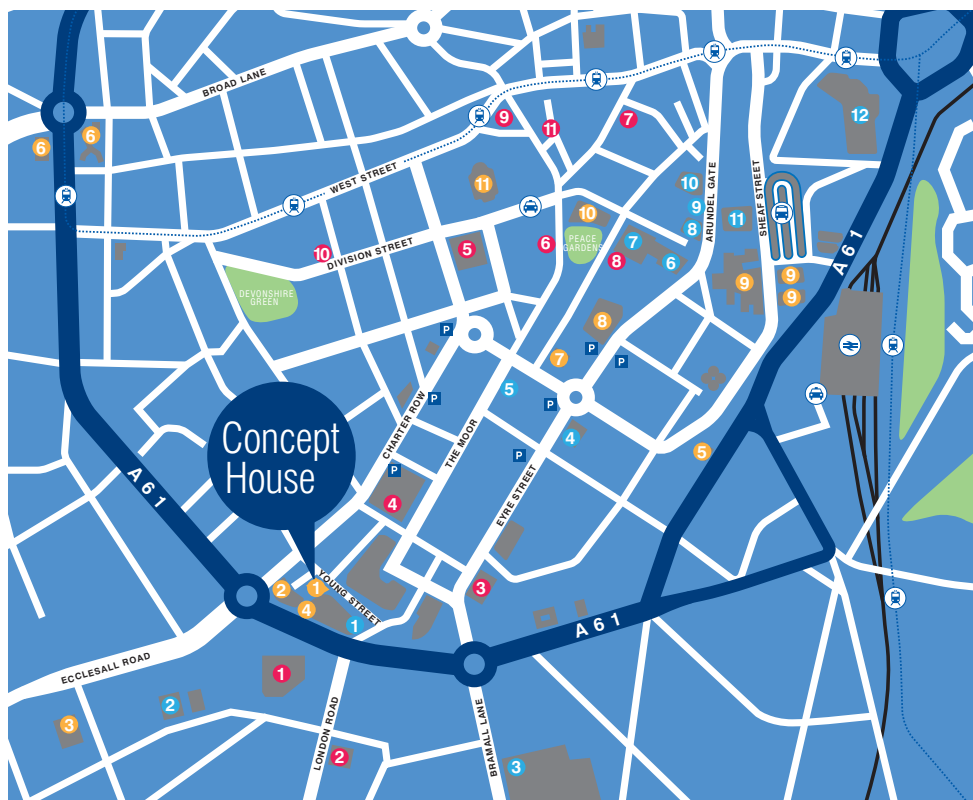
