Location

Egham is an affluent university town in the Borough of Runnymead in Surrey, with a large resident contingent of students close by at University of London, Royal Holloway College.

Located 19 miles to the west of London, it is well connected by the A30 and M25. Heathrow Airport lies approximately 3 miles to the north and Egham Station provides frequent services to London Waterloo.

Description

The unit forms part of an extremely attractive building and occupies a prime position fronting High Street.

The town has been significantly enhanced by the recent arrival of a new Waitrose and Travelodge and by mid-2021 the new Gateway West development opposite will see the inclusion of an Everyman Cinema, new retail units alongside 100 new homes and student accommodation.
