Location

Marlow is an attractive market town and established South East office centre, located 6 miles north of Maidenhead, 5 miles South of High Wycombe and 35 miles to the West of Central London.

Eclipse is located on Globe Park which is within close proximity to the A404, linking the town with Junction 4 of the M40 (3 miles) and Junction 8/9 of the M4 (8 miles). The M4 provides direct access on to Heathrow Airport.

Marlow railway station is 0.75 miles to the west, which provides services to London Paddington.
